

# INVESTOR CONFIDENTIALITY AGREEMENT

ANKKA AI DESIGN SYSTEM

This Confidentiality Agreement (“Agreement”) is entered into between:

ANKKA, represented by Irina Khvorostukhina, operator of the ANKKA AI design platform (ankka.eu)

and

## 1. Purpose

The Investor is evaluating a potential investment in ANKKA and its AI design technology platform.

In connection with this evaluation, ANKKA may disclose confidential information regarding:

- technology
- financial performance
- product development
- commercial pipeline
- strategic plans

## 2. Confidential Information

“Confidential Information” includes any non-public information disclosed by ANKKA, including but not limited to:

- AI models and datasets

- software architecture
- product design pipelines
- footwear design generation systems
- technical documentation
- financial projections
- cap table and ownership structure
- commercial partnerships and negotiations
- business strategy and roadmap

Information may be disclosed in written, digital, visual or oral form.

### 3. Use of Information

The Investor agrees to:

- use the Confidential Information solely to evaluate a potential investment
- not disclose the information to third parties without consent
- limit access only to partners, employees or advisors directly involved in the evaluation

### 4. Protection of Information

The Investor shall protect the Confidential Information with reasonable care, and at least the same level of care used to protect its own confidential information.

### 5. Restrictions

The Investor agrees not to:

- reverse engineer ANKKA technology
- replicate the AI design system
- disclose information to competing companies
- use the information for purposes other than evaluating the investment.

## 6. Exclusions

Confidential Information does not include information that:

- is publicly available
- becomes public without breach of this Agreement
- was already known to the Investor
- was independently developed without using ANKKA information.

## 7. Term

This Agreement shall remain in effect for five (5) years from the Effective Date.

Confidentiality obligations apply for five (5) years after disclosure.

## 8. Return or Destruction

Upon request, the Investor shall promptly return or destroy all Confidential Information.

## 9. Remedies

Unauthorized disclosure may cause irreparable harm.

ANKKA may seek injunctive relief and damages for any breach.

## 10. Governing Law

This Agreement shall be governed by the laws of Switzerland.

Any dispute shall be resolved by arbitration in Geneva under UNCITRAL rules.
